

Notice of Corn Delivery Policies

Effective November 12th, 2018

Dear Corn Delivery Driver,

Please be aware that Ingredion is now testing every inbound corn load for DON (vomitoxin) prior to unloading.

Loads which are above Ingredion London's acceptance limits for grade, moisture, and/or DON (vomitoxin) will be rejected.

Loads that are below Ingredion London's acceptance limits for grade, moisture, and DON (vomitoxin) will be subject to discounts and/or shrink if they are:

- At or above grade 3 for grading factors
- At or above 15.6% moisture
- At or above 3.1ppm DON (vomitoxin)

Please use channel 5 to communicate with the corn receiving operator. You may ask the corn receiving operator for the results of your load before unloading. Corn receiving operators are equipped to share results, but not the value of discounts to be applied. Ingredion's discount schedule can be found on the back of this notice.

You may choose to leave Ingredion's property without unloading in lieu of taking a discount.

Initial test results for DON (vomitoxin) will stand as final. Drivers that have left our site without unloading are not permitted to return to the site with the same load of corn.

Unloading of corn constitutes acceptance of any discounts or shrink for moisture, grading factors, and DON (vomitoxin) that may apply.

Corn delivered against wet corn contracts shall be greater than or equal to 16.5% and under 28% moisture.
Moisture adjustment discounts and shrink will be applied to deliveries with moisture at or above 15.5% in accordance with the "Moisture Adjustment Chart for Ingredion Canada Corporation".
Corn deliveries in excess of moisture limits or in excess of quality parameters above may be subject to rejection.
Discounts for grade, moisture, and vomitoxin are "stackable".*

Special Note: Buyer has the right to reject any shipment of corn at its discretion that does not meet contract specifications or which is adulterated. Any corn that is musty, contains insects, sour, heating or COFO are all subject to rejection.				
All corn must have no more than a maximum of 10 ppb aflatoxin.				
Corn delivered to Cardinal must have no more than a maximum of 2.0 ppm vomitoxin.				
Discounts for vomitoxin in corn delivered to London will apply between 3.1 ppm and 9.0 ppm as below and will be in addition to any discounts applicable for moisture and grading factors:
